## **INSPECTION AGREEMENT**

## This is intended to be a legally binding contract, please read it carefully.

**INSPECTION PROCESS.** This inspection, along with any subsequent re-inspections of the property conditions, is performed in accordance with the STANDARDS OF PRACTICE for **OREGON CERTIFIED HOME INSPECTORS,** included as part of the inspection report. **DISPUTE RESOLUTION.** All disputed claims, counterclaims, defenses, and other issues (including those based on contract, tort, negligence, or any other legal theory) related in any way to this inspection agreement or Inspectek West, Inc.'s inspection services shall be settled by binding arbitration in accordance to the laws of the State of Oregon, unless the parties mutually agree otherwise. In the event of a claim, the Client will allow Inspectek West, Inc. to inspect the claim prior to any repairs or waive the right to make a claim. The Client agrees not to disturb or repair or have repaired anything which may constitute evidence relating to the complaint, except in the case of an emergency.

**PAYMENT.** PAYMENT OF THE INSPECTION FEE IS DUE UPON THE COMPLETION OF THE INSPECTION. If the inspection fee is not paid in full within 10 days after the delivery of the report, there will be a late
